

East West Rail adds new drop-in event in Cambridge and addresses questions from communities

East West Railway Company (EWR Co) has added a new public drop-in event in Cambridge and published a range of new assets that respond to people's key concerns and questions following the updated route proposals for East West Rail (EWR).

These include:

- A new regular video series with the EWR Co team, which respond to the most prominent questions the team has received since the new proposals were published.
- An explainer animation on the considerations around the approach to Cambridge and serving the Cambridge Biomedical Campus.
- A range of factsheets on key matters – such as freight, powering EWR and specific proposals around Cambridge – that will be available at the forthcoming public drop-in events.

The event that's been added will be held on **Monday 17 July at Graduate Cambridge from 2pm-8pm**. It has been added to the series of existing events, which include events in Cambourne, Harston, Eversden and St Neots.

"I'm a strong believer in community involvement and we know individual residents, neighbourhoods, communities and businesses in the area will have questions about how the proposals affect them. I'm determined we respond to those questions and we've made a start on answering some of the key questions we receive in our new regular video series – 'Your Questions Answered'. I actively encourage people to continue asking us questions and to attend our public drop-in events in Cambridgeshire."

Last month EWR Co published the latest proposals for EWR, which follow extensive consultation with the public that generated nearly 10,000 responses. The updated plans cover:

- A southern approach to Cambridge that best serves the Cambridge Biomedical Campus, which is an unparalleled centre for life sciences of global importance and home to Addenbrooke's Hospital.
- Potential opportunities to remove or reduce the height of approximately half the embankments or viaducts (by length) compared to what was shown at the 2021 consultation.
- How EWR will improve quality of life for people in Cambridgeshire by providing fast, reliable and affordable public transport, taking more cars off the roads and reducing congestion, which will allow more people the chance to live within easy access of the city in less expensive housing areas.

The events are designed to ensure everyone has an opportunity to speak to the EWR Co team about their individual situations and circumstances and what the updated proposals mean for them. They will allow residents to find out more about the new EWR proposals, ask questions, understand the next steps in the Project and provide opportunities to meet the EWR Co team face-to-face. The sessions are open to everyone, with the Bedfordshire events taking place on:

- Thursday 22nd June in Eversden, at Eversden Village Hall, from 2pm – 8pm
- Monday 26th June in Harston, at Harston Village Hall, from 2pm – 8pm
- Tuesday 11th July in Cambourne, at the Cambridge Belfry Hotel, from 2pm – 8pm
- Monday 17th July in Cambridge, at Graduate Cambridge, from 2pm – 8pm
- Thursday 20th July in St Neots, at Love's Farm, from 2pm – 8pm

The events in Cambridgeshire are part of a series of drop-in sessions for communities across the route between Oxford and Cambridge. They do not form part of the statutory public consultation, which will include even more detailed proposals and is expected to take place in the first half of 2024.

About the East West Rail project

East West Rail intends to create a new direct connection between Oxford and Cambridge. Serving communities across the area, it intends to bring faster journey times and lower transport costs as well as ease pressure on local roads.

East West Rail is planned to be delivered in three Connection Stages:

- Connection Stage One: Oxford to Bletchley and Milton Keynes
- Connection Stage Two: Oxford to Bedford
- Connection Stage Three: Oxford to Cambridge

Network Rail was responsible for developing the first part of the East West Rail, connecting Oxford with Bicester, and is a partner in a construction alliance to deliver Connection Stage 1 of the project, where East West Railway Company (EWR Co) and Network Rail are acting as the Department for Transport's joint sponsors.

EWR Co is now developing the route to enable services to run to Cambridge via Bedford and plans to seek statutory powers under the Planning Act 2008, following a period of extensive consultation.
